Active Membership may be extended to any person who is the chief administrative head of the police department, or whatever title they may be called, of any incorporated city or town, institution of secondary or higher education, public junior college, airport police, or transit police in the North Texas area.

Associate membership may be extended to any person who is certified by TCOLE as a police officer who serves as assistant chief, or whatever title they may be called, that is the next level of command below chief, sponsored by the agency's chief, or the special agent in charge of any federal law enforcement agency. Associate Members shall not be eligible to vote. Associate members may attend and join discussions at meetings and conferences, but cannot hold elected office.

Honorary Membership may be extended to any person who is certified by TCOLE as a police officer who serves at a rank immediately below the second level of command in a or hold elected office.

Corporate Members: Any company having an office or conducting business in the State of Texas may become member of the association, after approval of the Executive Board and the payment of appropriate dues. Corporate members shall not be eligible to hold office or to vote, but shall have the privilege of having representatives attend and join in the discussions at all official meetings, unless otherwise designated by the President.
